



The Executive Cabinet Commonwealth of Redmont

Thursday, January 16th, 2025

To the House of Representatives,

We, the Vice President and the undersigned Secretaries, send you this in the most unfortunate and urgent circumstances. It is our belief that President UnityMaster is no longer fit to discharge the duties and responsibilities of the Office of the President, and as such we declare UnityMaster to be incapacitated. To prove this, let these facts be known:

He has failed to sign bills for weeks and months.

He has signed amendments to the Law without communicating with the Departments they affect.

He has signed illegal Executive Orders.

He has signed Executive Orders without communicating to the Departments therein.

He has failed to respond to members of his Cabinet.

He has failed to communicate with the Vice President on pressing matters.

He has failed to enforce the Executive Orders that he signs.

He has failed to provide transparency of his actions to the public.

He has appointed himself as the DCT Secretary, and then proceeded to neglect the necessary duties of a Secretary.

Considering all these facts listed above, we believe it is in the best interests of the good of the Commonwealth that he declared unfit for office and removed from his position. We acknowledge the gravity of such a request, and would like to note it was not one made lightly. However, it is our firm belief that the necessity of good governance takes precedence. Attached, in the following pages, we have submitted evidence of these facts, or accounts of those affected:

He has failed to sign bills for weeks and months.

Secretary Requirements Act: Passed Congress October 16, 2024. Unsigned while in office for 82 days.

Judicial Officer Activity Requirements Fix Act: Passed Congress October 16, 2024. Signed 45 days later.

New Player's UBI Increase Act: Passed Congress October 16, 2024. Signed 43 days later.

Jail Abuse Fix Act: Passed Congress October 16, 2024. Signed 43 days later.

Licenses Act: Passed Congress October 16, 2024. Signed 35 days later.

Less Mandatory Polling Spots Act: Passed Congress November 8, 2024. Signed 22 days later.

Taxation Exemption Fix Act: Passed Congress October 22, 2024. Signed 19 days later.

Assault-Murder Rebalance Act: Passed Congress October 22, 2024. Signed 17 days later.

Put a Ring on It Act: Passed Congress December 19, 2024. Signed 15 days later.

A notable exception:

Presidential Re-election Act: Passed Congress January 1, 2025. Signed 2 days later.

Additionally, the *Presidential Re-election Act* is a complex change and thus must go to referendum before being ratified into law. However, the President signed it into law and announced it, disregarding advice to have it go to referendum.

The signage of bills into law is one of the simplest and most important duties of the President; it must be done in a timely manner to ensure an effective legislature. The President has failed the Commonwealth in this regard; many important bills have gone unsigned for weeks and some over a month.

He has signed amendments to the Law without communicating with the Departments they affect.

Assault-Murder Rebalance Act., signed November 8, 2024. The President failed to notify the Department of Homeland Security of this amendment that affects how the law is enforced by them.

Credit Standards Act, signed November 10, 2024. The President failed to notify the Department of Justice of this new law they would have to investigate and prosecute.

Licenses Act, signed November 10, 2024. The President failed to notify the Department of Homeland Security of this new law they would have to enforce.

Less Mandatory Polling Spots Act., signed December 1, 2024. The President failed to notify the Department of State of this amendment that affects their department.

It is the duty of the President not only to sign bills into law, but to ensure they are enforced properly. Some bills require proper enforcement from the Departments, and in every case here, he did not inform them, the Vice President did after noticing he did not.

He has signed illegal Executive Orders.

Executive Order 02/25: Increasing Universal Basic Income Disbursement, signed January 6, 2025. At the time this was signed, the President could only raise UBI to \$5.

Executive Order No. 3/2025: Declaration of the Netherite Standard for the Redmont Dollar, signed January 7, 2025. The President has no authority over the actions of the Federal Reserve Bank. The President cannot require financial institutions, businesses, and all other entities within Redmont to recognize the Netherite backed Redmont Dollar as the sole legal tender. The President cannot spend government funds in a way that conflicts with Congressionally approved appropriations.

Executive Order No. 5/2025 Mandating the Resumption of the Pruning Tax for Netherite Acquisition, signed January 7, 2025. The President cannot spend government funds in a way that conflicts with Congressionally approved appropriations. The President has no authority over the actions of the Federal Reserve Bank.

These attempts to act on something outside of the power of the President opened the door for lawsuits to be made and undermined the integrity to the law that the President must follow.

He has failed to respond to members of his Cabinet.

All Secretaries undersigned can give accounts on their lack of response and communication from President UnityMaster. Here are a few comments said by the Secretaries, anonymized:

“When I asked him to revise an Executive Order or give input on something after he asks me to, he’d ignore it for days until I remind him enough to respond”

“Most of his Presidency can be characterised as more active in DMs and #politics than actually governing and doing his duties.”

“He ghosted me like 10 times.”

“Unity not only has shown his ineptitude for this role but lacked communication to us in regards to laws passed.”

He has failed to communicate with the Vice President on pressing matters.

The Vice President was not made aware of the President's deportation on January 7th until hours later by an informant who will remain anonymous. If it were not for the informant, the Vice President likely would have been left in the dark for much longer. During that time, there was no one who could fulfill necessary duties of the President, including hiring/firing Cabinet members, communicating with the Cabinet on the discord servers, communicating with the public on with announcements, making nominations, among other duties.

He has signed Executive Orders without communicating to the Departments therein.

Executive Order - 29/24: Agricultural Stockpiles Initiative, signed November 28, 2024. The Department of the Interior and the Department of Construction & Transport were not communicated with before the President signed this Executive Order, which creates a large amount of work for the supply side of the Department of the Interior, and requires the construction of several caverns in the mountain sides of Willow.

Executive Order 32/24 - Mandatory Tendering of Government Supplies, signed December 1, 2024. The Department of the Interior was not communicated with before the President signed this Executive Order, which creates a large amount of work for the supply side of the Department of the Interior.

Executive Order - 31/24 Military Reserves, signed December 1, 2024. 2024. The Department of the Interior was not communicated with before the President signed this Executive Order, which creates a large amount of work for the supply side of the Department of the Interior.

Executive Order 38/24 Establishment of UniCare and Project MediPrivate (Yakcare), signed December 29, 2024. The Department of Health shared many concerns regarding this Executive Order, and despite that, the President still signed it. This Executive Order completely overhauls the medical system for the Department of Health, and despite the Secretary saying that they “cannot enact it,” he signed it. After sharing more questions and concerns, President UnityMaster did not respond.

Executive Order No. 07/2025: Monthly Economic Report and Auditing Mandate, signed January 7, 2025. The Department of Commerce was not communicated with before the President signed this Executive Order, which requires the Department of Commerce to undertake a very large amount of work. Additionally, the leadership in the Department of Commerce shared many concerns regarding this Executive Order.

Communicating with the Departments beforehand is essential to ensure the proper enforcement of any Executive Order, and must be done to provide the transparent leadership required for good governance. These Executive Orders and how President UnityMaster communicated them were far less than ideal, and created issues for the Departments therein.

He has failed to enforce the Executive Orders that he signs.

Executive Order - 26/24 Sovereign Wealth Fund, signed November 25, 2024. The Sovereign Wealth Fund Board has failed to publish their monthly required transparency reports.

Executive Order - 29/24: Agricultural Stockpiles Initiative, signed November 28, 2024. The President has failed to make any progress on the construction of the required stockpile caverns. The President has failed to appoint any members to the Agricultural Commission.

Executive Order - 30/24 Redmont Sporting Commission, signed November 29, 2024. The President has failed to action anything regarding the Redmont Sporting Commission, with the exception of appointing three board members.

Executive Order - 31/24 Military Reserves, signed December 1, 2024. The President has failed to create any military reserves.

Executive Order 32/24 - Mandatory Tendering of Government Supplies, signed December 1, 2024. The President has failed to require departments to provide materials lists.

He has failed to provide transparency of his actions to the public.

The President nominated TheReal42Person to the position of Secretary of the Department of State on November 10, 2024. This nomination and its passing were never announced.

The President nominated v__d to the Federal Reserve Board on November 13, 2024. This nomination and its passing were never announced.

The President nominated Dusty_3 to the position of Justice on December 9, 2024. This nomination was announced 18 days after passing.

The President signed the *Appropriations Act - NOV 2024* on November 1, 2024. Its signage was announced 23 days later.

The President signed the *Assault-Murder Rebalance Act* on November 8, 2024. Its signage was announced 16 days later.

The President signed the *Taxation Exemption Fix Act* on November 8, 2024. Its signage was announced 16 days later.

The President signed the *Credit Standards Act* on November 10, 2024. Its signage was announced 14 days later.

The President signed the *Substantial Holdings Act* on November 10, 2024. Its signage was announced 14 days later.

The President signed the *Salary Modifications Act* on November 10, 2024. Its signage was announced 14 days later.

The President signed the *Licenses Act* on November 10, 2024. Its signage was announced 14 days later.

The President signed *Executive Order 33/24 - Establishment of Department Shoutouts* on December 9, 2024. Its signage was announced 20 days later.

The President signed *Executive Order 34/24 - Establishment of the Private Accreditation System for Specialized Education* on December 10, 2024. Its signage was announced 19 days later.

The President signed *Executive Order 35/24 - Establishment of the National Welfare Office* on December 10, 2024. Its signage was announced 19 days later.

The President signed *Executive Order 36/24 - Recognition of Oakridge's Cultural Excellence* on December 10, 2024. Its signage was announced 19 days later.

The President signed *Executive Order 37/24 - Establishing Formal Process for Arts and Artifacts Purchases* on December 19, 2024. Its signage was announced 10 days later.

The President is an elected official of the public, and owes the public the transparency of his actions in a timely manner, however, in almost every case, he has failed to do so.

He appointed himself as the DCT Secretary, and then proceeded to neglect the necessary duties of a Secretary.

Though the exact time is unknown, as it was not announced, President UnityMaster appointed himself as Acting DCT Secretary, without notifying the public, the Vice President, the DCT, or even the DCT Secretary at the time- The_Superior10. Looking at logs, it was sometime at or before December 26, 2024.

The DCT, including The_Superior10, were left in the dark during all of this. At the time, The_Superior10 had been approving projects and payments, as the DCT Secretary does. It should be noted that UnityMaster and The_Superior10 were both hired with the DCT Secretary role at this time- which is illegal.

Around three days after his appointment, on December 29, 2024, UnityMaster first told the DCT that he was in fact the Secretary, after he promoted two employees to Construction Manager. Promotions are typically done by vote among managers, not solely decided by the Secretary. This failure to communicate caused instability and conflict within the department.

Additionally, the department owed hundreds of thousands of dollars to citizens and contractors. These payments had to be actioned by the Secretary, but due to his inaction, everyone who was owed money was unpaid for several days.

As an employee of the DCT put it, “*The President neglected the department in general, rarely answering questions or giving any guidance to the department.*”

After Katto’s appointment to Acting DCT Secretary on January 9, 2024, as an employee of the DCT put it, “*The department was completely turned around within a day of having an active secretary.*”

Other comments from Secretaries.

"He has threatened to fire other Cabinet members for disagreeing with the President's personal beliefs."

"I think Unity would be better off resigning or something because these true allegations made himself look bad, and if it wasn't bad enough he wouldn't talk to us on issues that may need our attention."
